1. INTRODUCTION AND DOCUMENTS TO BE SUBMITTED

Pursuant to article 178 of the Ordinance for Radiological Protection (StSV or ORP), a qualification in radiological protection received abroad can be recognised when it is equivalent to the Swiss qualification. Recognitions of qualifications in radiological protection received abroad will be examined on an individual basis. The recognition of the expertise of medical physicians is only possible in the case that the foreign medical diploma and the postgraduate title have firstly been recognised by the medical profession commission MEBEKO. - Copies of the professional and university diplomas
- Copies of the certificates issued by MEBEKO recognising the medical diploma and the postgraduate titles (only for physicians)
- Copies of the attendance certificates and/or attestations for all completed training and courses relevant to radiological protection
- Any applicable additional complementary and supplementary information that could be helpful for the examination
